

## Permanent Resident Status, Work Permits, and Study Permits Issued in Canada and Atlantic Canada in 2024

In this article, we present statistics on new permanent resident status, work permits, and study permits issued in Canada and for Atlantic Canada in 2024. These statistics are derived from the dataset released to ARGEIAD by Immigration, Refugee and Citizenship Canada (IRCC, Research and Data Branch).

### Provincial Distribution of Permanent Resident Status Granted

In 2024, a total of 483,595 permanent resident (PR) status were granted in Canada out of which 8.2 percent were in Atlantic Canada. Among the four Atlantic provinces, New Brunswick hosted the largest number, while Prince Edward Island hosted the fewest. (Table 1).

The list of top five source countries was identical in Canada and Atlantic Canada but comprised just about half of all PRs in Canada, while 57 percent in Atlantic Canada. India was the top source country of PRs both nationally and in Atlantic Canada. (Tables 2 and 3a).

When data were disaggregated by Atlantic province, India ranked at the top in all provinces except Newfoundland and Labrador, where it was second to the Philippines. Afghanistan, Algeria, Hong Kong, Korea, Syria, Ukraine, and Vietnam appear on the top five source countries' list in some individual provinces but not regionally, which could reflect different appeals of each province to the newcomers attributed to immigrant attraction initiatives. ### Provincial Distribution of Work Permits Issued

Nationally, 910,150 work permits were issued in 2024, about 5 percent were for Atlantic Provinces (Table 4).

The composition of the top five source countries of new work permit holders in 2024 matched that of PRs (reported in Table 1), except for the absence of China and the inclusion of Ukraine in the second place (following India). Together, the work permit holders from the top five source countries comprised about half of the total work permits issued by Canada in 2024.

Work permit holders from the top five countries in Atlantic Canada comprised about 62 percent of their total in the region. India was the top source country of new work permit holders in Atlantic Canada as well, close to twice their numbers from the second top source which was the Philippines. Mexico was also included in the regional list, but not nationally (Table 6a).

The top five source country composition was slightly different when individual Atlantic provinces are considered as Jamaica, Iran and China also found a place on the list in NS, NL and PEI. (Table 6b).

### Provincial Distribution of Study Permits Issued

In 2024, Canada issued 518,350 new study permits. About 4.7 percent of study permit holders were destined for the Atlantic provinces, with Nova Scotia being their top destination. (Table 7)

Nationally, about 62 percent of new study permits were issued to Indians, making their country the top source country of study permit holders. China was in a distant second place.

In Atlantic Canada as well, India was the top source country of study permit holders, although in PEI it was the fourth largest source, Taiwan being the top there. Nigeria became the second largest source in the region, followed by the People's Republic of China. Ghana was also among the top five sources, while Algeria was not (despite having a place on the national list). There were some variations between provinces. (Tables 9a and 9b).

## Summary

Although Atlantic Canada was home to about 6.4 percent of Canadians, it was the intended destination of more than 8 percent of new Canadian PRs in 2024. The top five source countries of PRs comprised about 57 percent, leaving a diverse mix of countries to form the remaining 43 percent. The source country composition was identical to their national composition. The largest number came from India. The Philippines was a distant second source.

About 5 percent of new work permit holders in Canada had declared Atlantic Canada as their intended destination, with India being the top source with more than double the numbers coming from the Philippines, the second top source. Ukraine and Mexico were also in the list of the top five sources in the region, but not nationally.

About 5 percent of Canadian study permits were issued for Atlantic Canada, with India being the top source, followed by Nigeria, where 40 percent fewer permits were issued for Atlantic Canada.

Some source countries of new arrivals are from war-torn countries such as Afghanistan, Syria, and Ukraine. They appear in some provinces, but not all, perhaps due to deliberate attempts by their local communities or religious organizations in those provinces to attract them.

Resident immigrant communities attract new arrivals. The finding that both new permanent and temporary resident permit holders destined for Atlantic Canada originate in a diverse mix of countries is reflective of there being smaller resident immigrant communities in the region.
