Work Plan for Authoritative Voice SMU Interpreting Services

One interpreting skill that is important when working with Deaf professionals is that of 'authoritative voice'. In our ASL to English interpretations we need to be cognizant of the quality of our voice to accurately represent the signer's message, and this includes the tone, prosody, vocabulary choices, etc.

Work Plan 1: Improving Authoritative Voice for A-E Interpreting

Notes from Dr. Campbell: I don't agree with #6 or #10 -- there are cultural aspects and the article is very much focused on White western culture. For example, I am not going to shake hands "firmly" with people from many eastern African or south African countries as it is very rude, while people from south Asia and some parts of Europe will nod a lot. But there is a lot of truth in this, e.g., interpreters who establish their own authoritative body language will tend to modulate their interpreting as a result.
