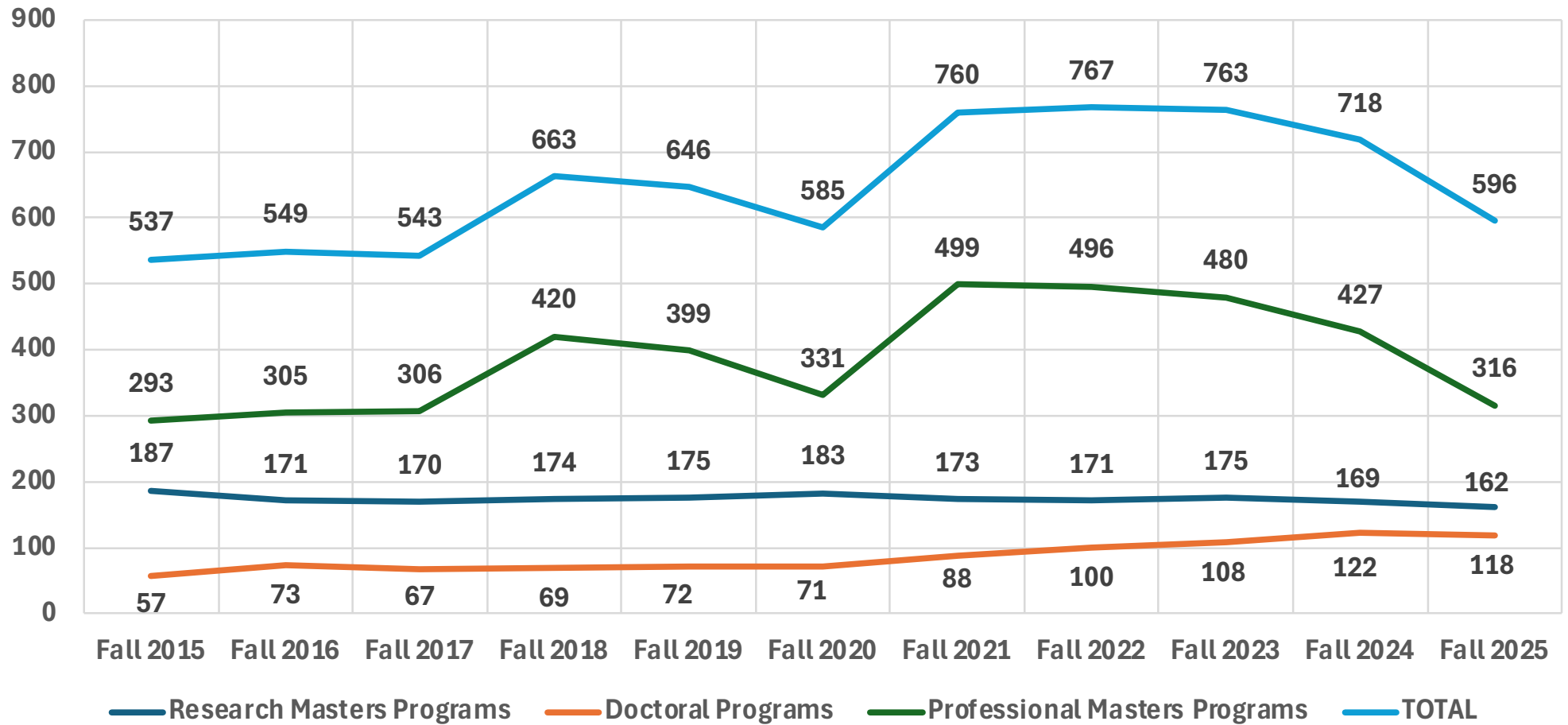

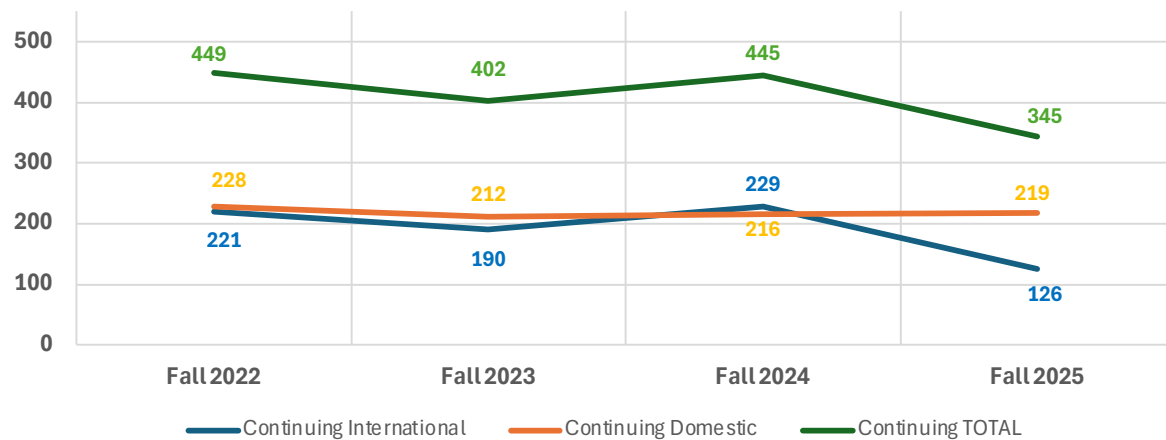

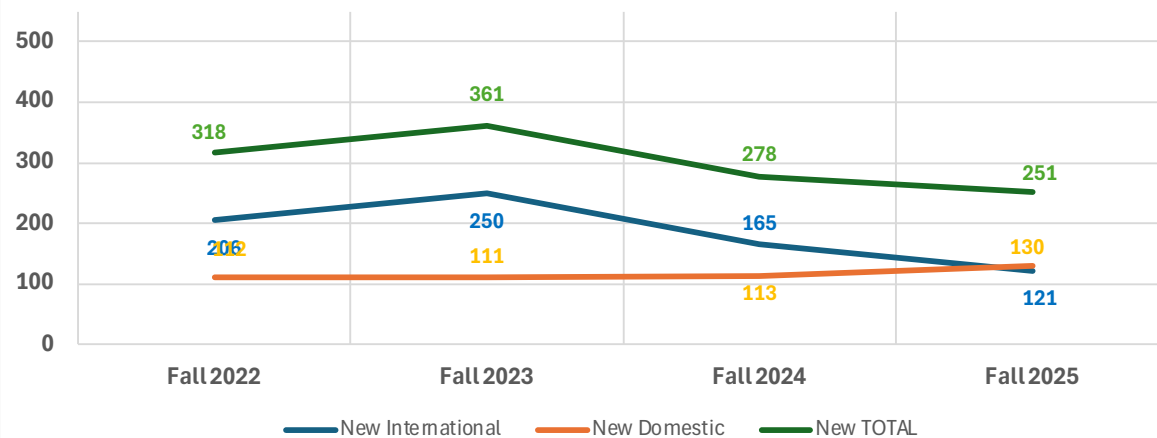

report TA funding this year since it was outside FGSR view)*

FGSR Graduate Awards and Fellowships = \$1,520,005

Named Awards = \$467,607

Durland Scholarships in Graduate Research = \$235,000

Program Scholarships = \$167,250

## Last Graduate Student notes:

- We have been doing more “professional development” sessions, organized through FGSR Associate Dean (e.g. with career services for resume prep / job search info).
- The non-credit FGSR “University Teaching” course is paused for the moment (as we lost the primary person who taught it for years - Will Kay), and we are looking at moving to a new model which could allow professors to volunteer to do modules (lectures) that fit into an overall “course package”. Hopefully we can try it next academic year.
- Have been informing professors (through Research Update emails) about webinars available through the CAGS National Community of Practice on Graduate Supervision.
- Have rolled out a voluntary Mentorship Agreement form that we hope more supervising professors will go through with the grad students.

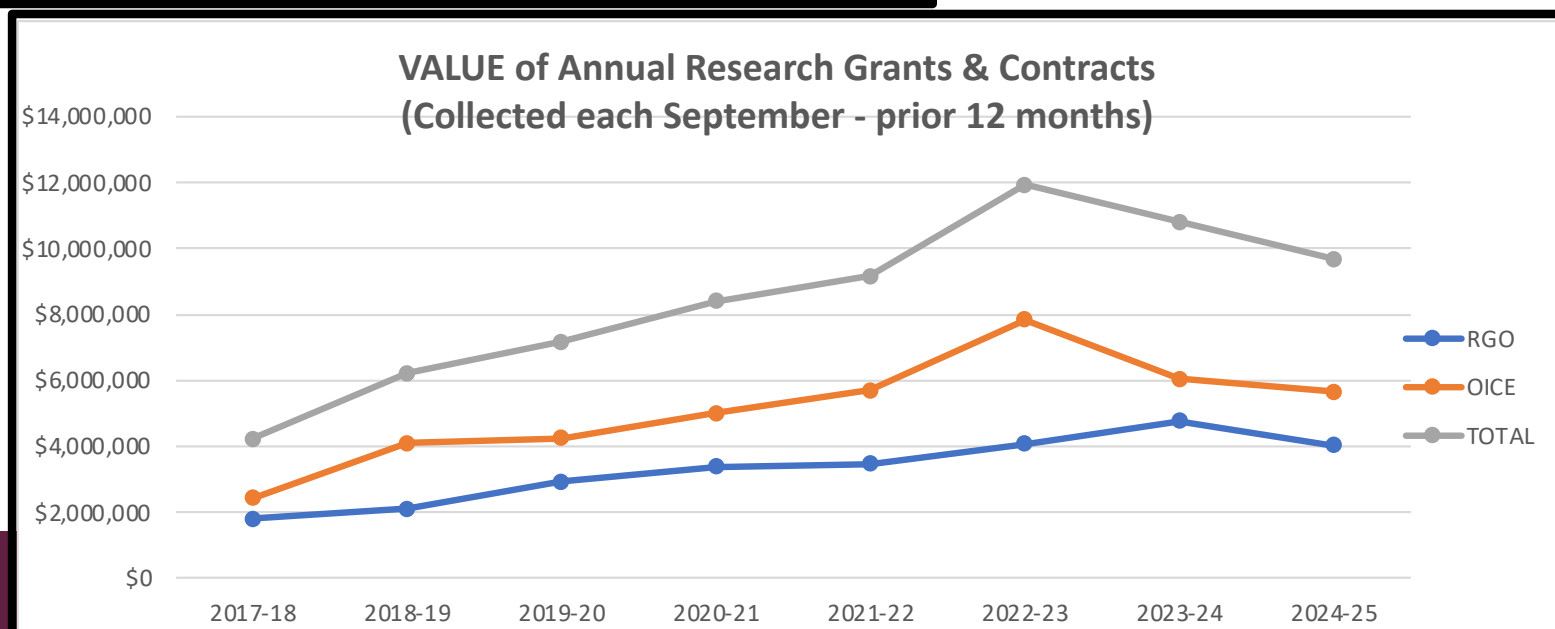
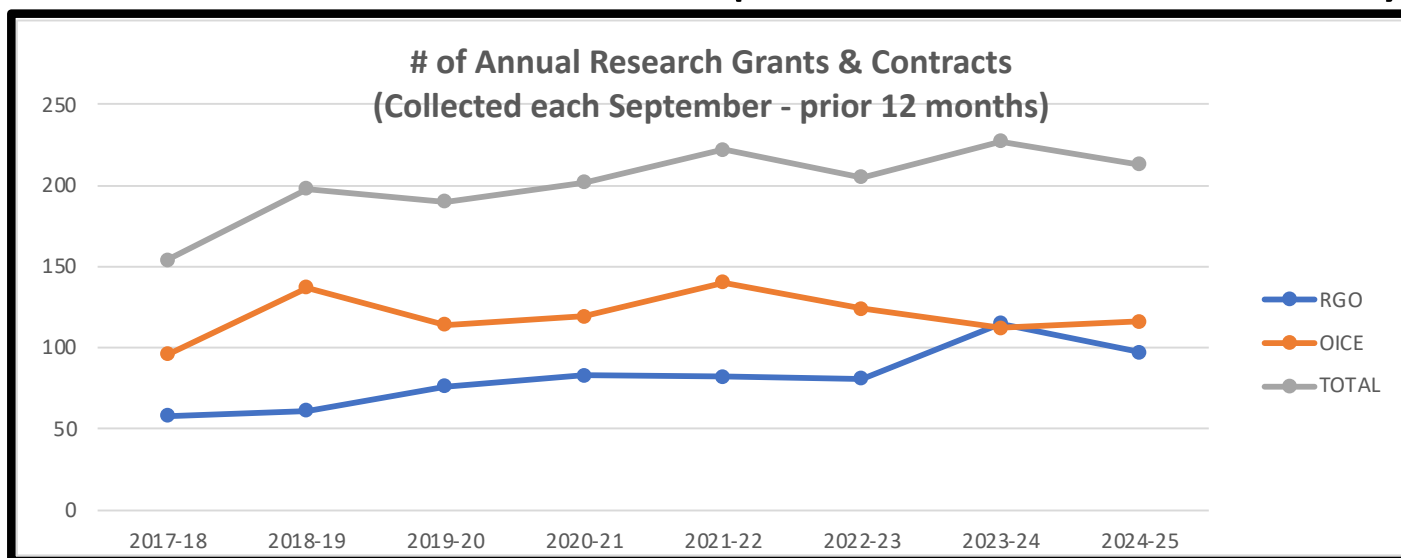

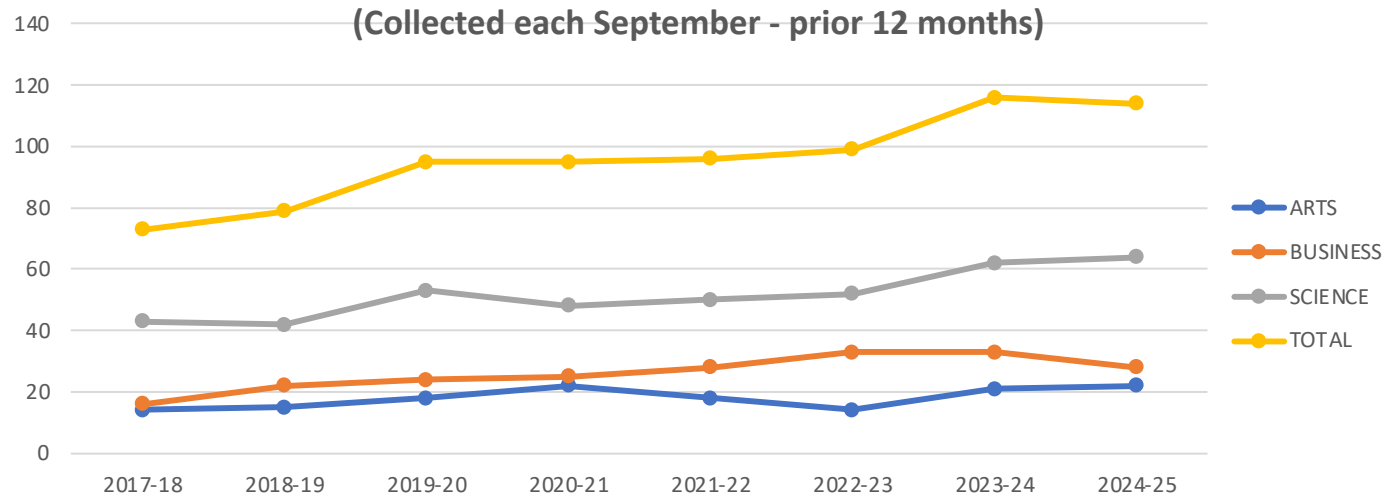
Charting 8 year progression – by Grant or Contract (facilitated by RGO or OICE)  
(CRCs not included in this table)



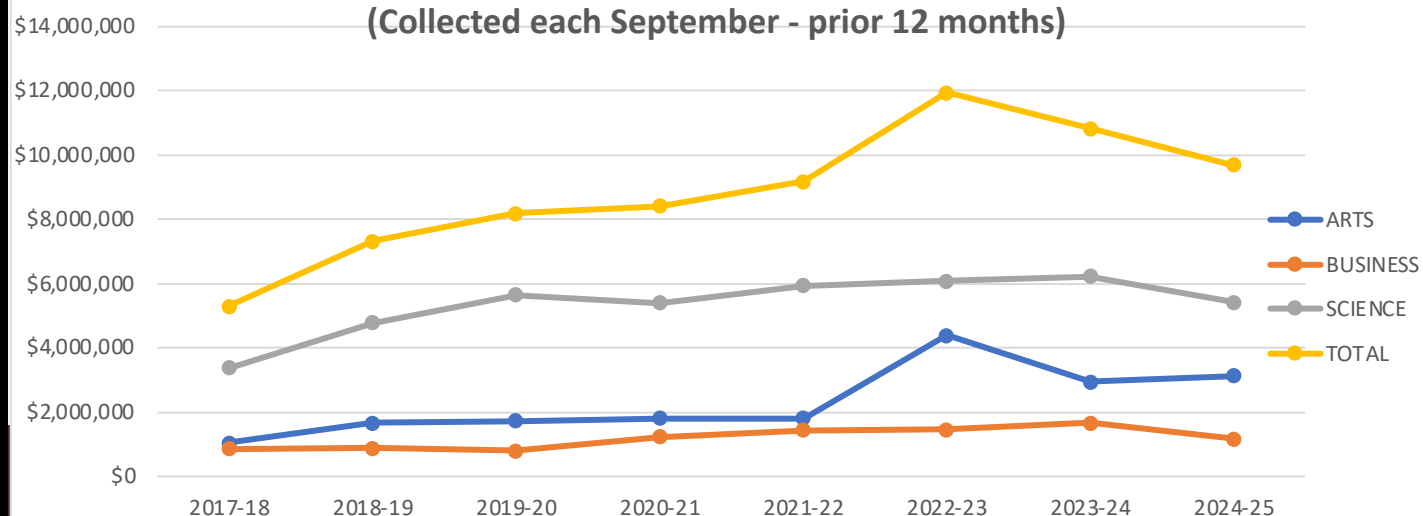

(Collected each September - prior 12 months)



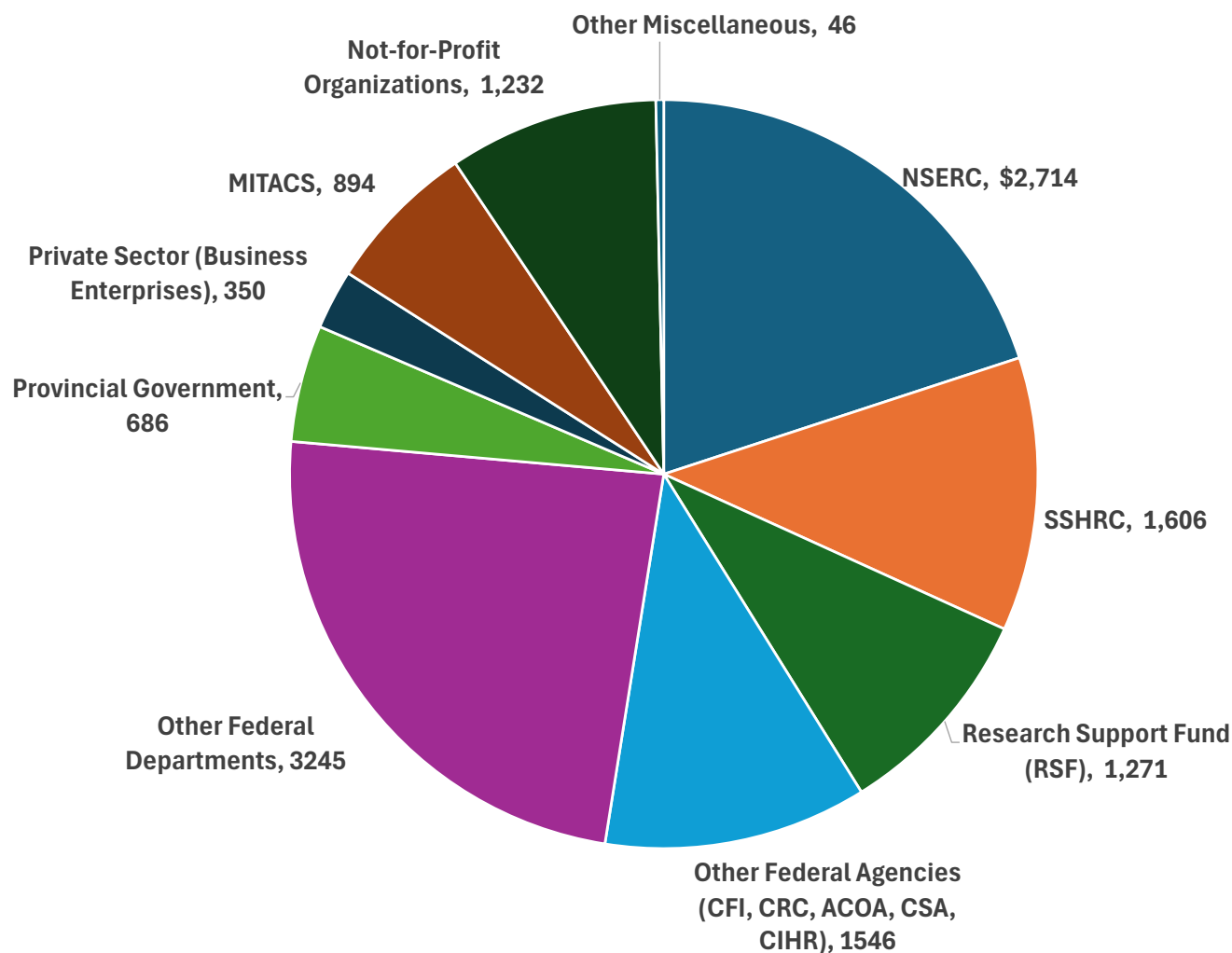
VALUE of Annual Research Grants & Contracts

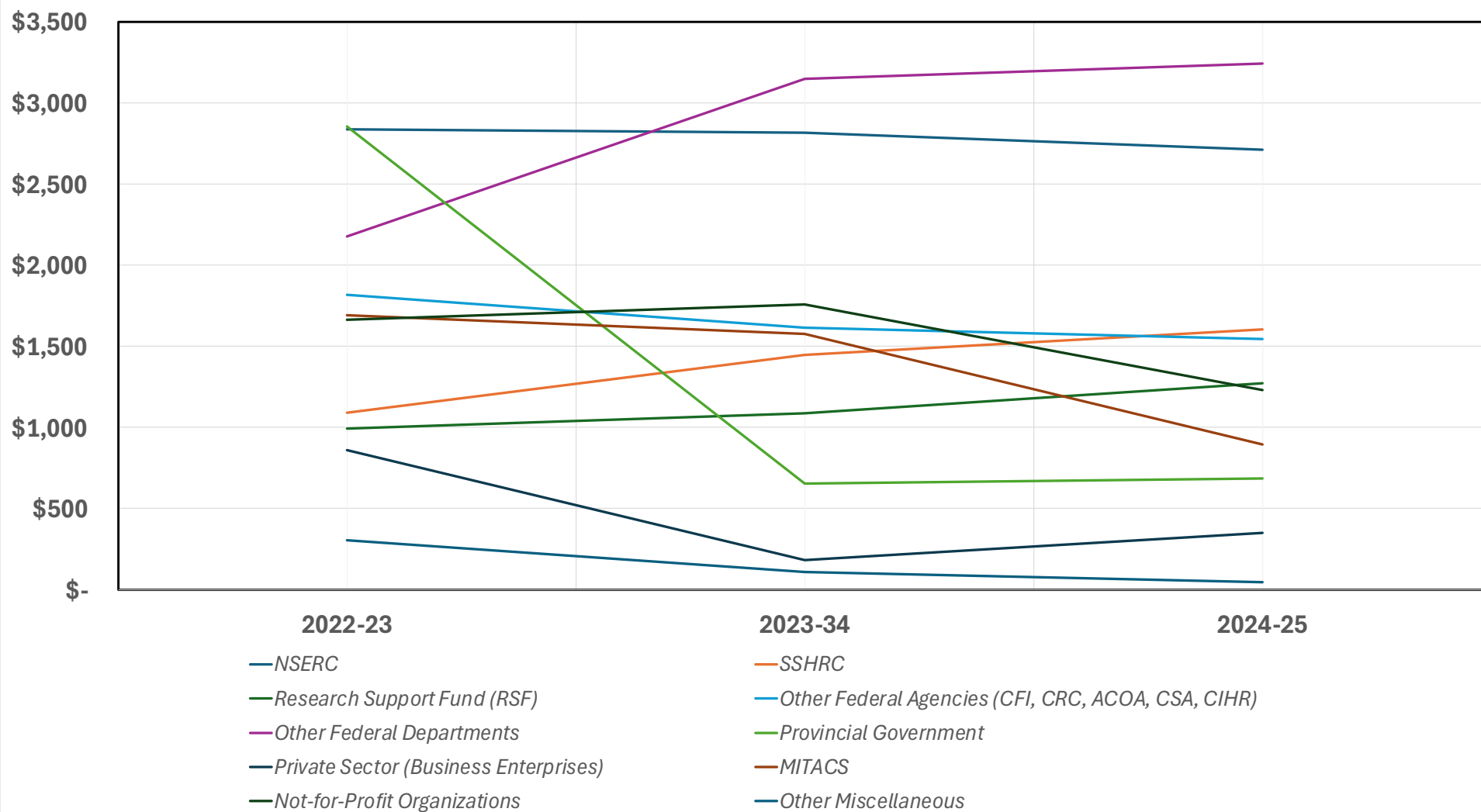

## **REMINDER – Research Agreements Policy:**

- see our FAQ Page for Applying for Grants & (mostly) Contracts (<https://www.smu.ca/fgsr/fgsr/grants-agreements-faq-for-faculty.html>)
- the process for applying for contracts, and getting assistance/support is outlined, including ensuring early connection with Office of Innovation and Comm Engagement (OICE) within FGSR
- other notable part of the Policy:
  - **Simplified policy** for university required charge for “overhead” (indirect cost of research): minimum is **flat rate of 20% of total direct research costs**
  - The use (or distribution) of this collected overhead includes re-directing a portion back for use by the professor holding the contract (**20% of the collected overhead is re-directed back this way to the PI**)

## **Research Data Management:**

- Federal Tri-Agencies \*have\* moved forward on implementing a national Research Data Management Policy ([https://www.science.gc.ca/eic/site/063.nsf/eng/h\\_547652FB.h tml](https://www.science.gc.ca/eic/site/063.nsf/eng/h_547652FB.h tml))
- Next steps:
  - Inclusion of Research Data Management (RDM) Plans will be required on selected grant program applications
  - all universities have **public RDM Institutional Strategies** (to remain eligible for TriAgency funding) ...

**SMU's is NOW POSTED on our FGSR Research page!**

- Assistance locally with RDM experts in Library – Peter Webster (lead)

## **REMINDER – Spending & Hiring using your Research Grant Accounts:**

- Realize that keeping up with proper processes, and allowances/eligibility, can be challenging (including using/interpreting our tools)
- Now with Tri-Agencies “Principles-based Accounting”, we do not have special NSERC/SSHRC “books” anymore to say what research expenses are eligible and which aren’t ...

Rather, ALL SMU research-account spending is governed by same set of guiding principles to determine eligibility:

## **REMINDER – Spending & Hiring using your Research Grant Accounts:**

- Rather, ALL SMU research-account spending is governed by same set of guiding principles to determine eligibility:
  - **contribute to the direct costs of the research/activities for which the funds were awarded, with benefits directly attributable to the grant**
  - **not be provided by the administering institution to their research personnel**
  - **be effective and economical**
  - **not result in personal gain for members of the research team**
- Have Developed a “**Researcher Accountability Statement**” that we **emailed around a year or so ago** – addresses many areas of concern noted at our last Tri-Agency audit: **will implement in next 1-2 weeks (all grant holders will get an email with the form)**

    - Family Services of Nova Scotia – Research Collaboration
  - SMU Advancement is supporting search for other funding opportunities for CER
  - Increasing engagement with other Canadian CER entities (SFU, McMaster, CCECanada) to promote knowledge sharing among CER faculty and staff
- Engagement with Government
  - Continue to engage faculty and students with government
  - Our primary relationship with OPIN (Office for Public Sector Innovation) has diminished as their role has been minimized within the NS Government.
- 2025 Project Funding (~\$112K)
  - 15 projects funded
  - 4 involving SMU faculty as PI

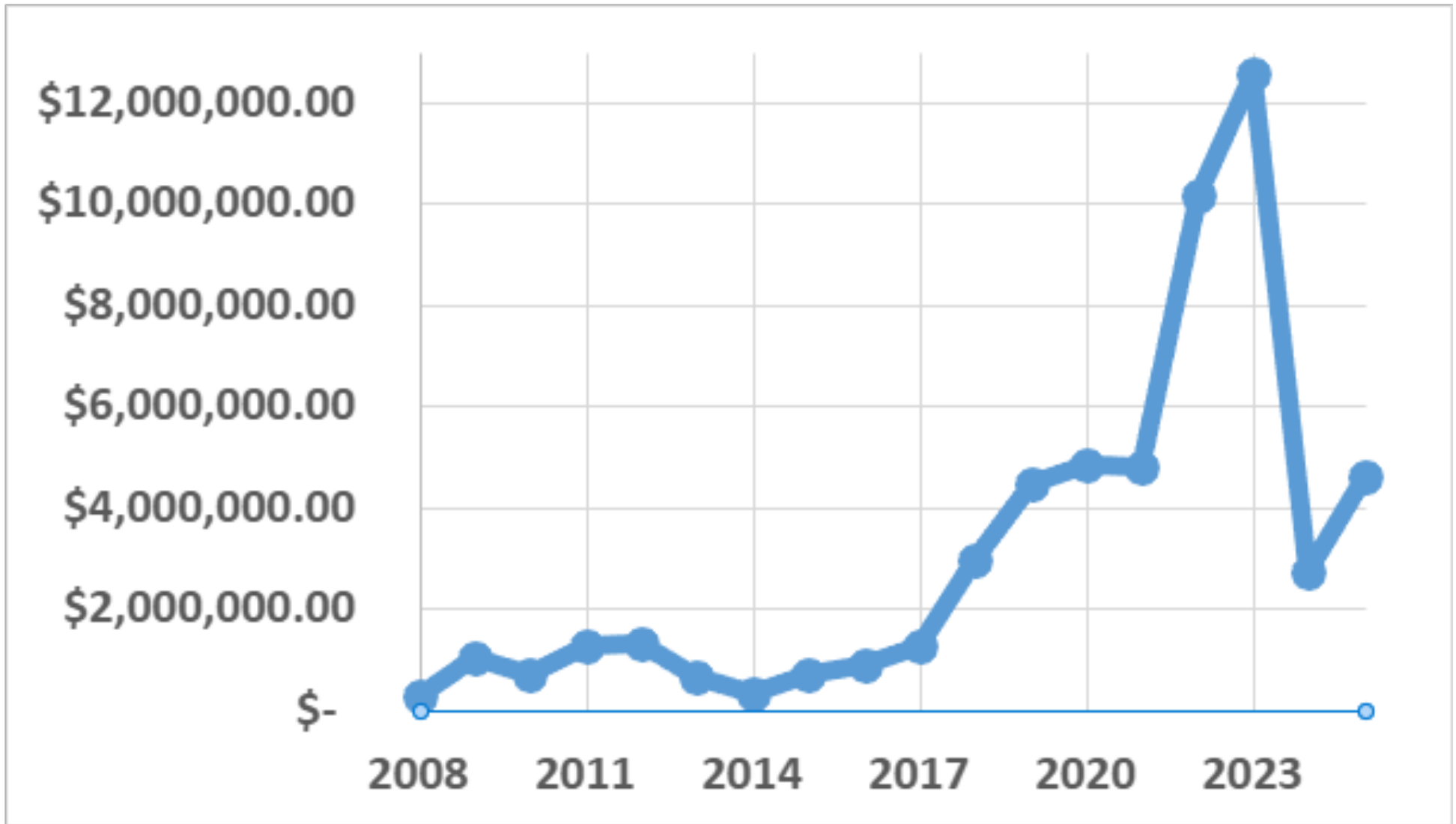
